**Presenter Biographies**

**Robert H. Snedaker III ("Chip")**

Attorney Robert H. Snedaker III ("Chip") is an attorney with nearly thirty years of legal experience. He is an Ohio State Bar Association, Certified Specialist, Family Relations Law. His practice is limited to divorce, dissolution, and other family relations law issues. Chip has given presentations and written articles for the Ohio State Bar Association, the Columbus Bar Association, the Ohio Psychological Association, and many other organizations. He is a frequent speaker at seminars for lawyers and non-lawyers. He has spoken and written about many family law issues and concerns. He is a founding member of the Collaborative Divorce Professionals, Inc., an association advocating use of the collaborative divorce process as an alternative to traditional contested divorce. His membership has included service as president and on the board of trustees. He graduated from Ohio University in 1978, cum laude, with a Bachelor of Business Administration degree. He obtained his Law Degree (Juris Doctorate) from Capital University Law School in 1981.

**James A. Hanneman**

Attorney James A. Hanneman ("Jim") is a partner at Dougherty, Hanneman & Snedaker, LLC, in Columbus, Ohio. The firm limits its practice to divorce, dissolution, and other family law matters. Mr. Hanneman has practiced for 15 years and is certified as a specialist in Family Relations Law. He previously served as the Chairman of the Family Law Committee of the CBA. Mr. Hanneman is a member of the Collaborative Divorce Professionals handling numerous collaborative cases each year. Mr. Hanneman also

serves as a referral attorney for Choices and Turning Point, two central Ohio domestic violence groups that provide services for victims of domestic violence. Mr. Hanneman is licensed to practice law in the states of Ohio and Georgia.

#### **Joseph L. Piccin**

Joseph L. Piccin attended Miami University in Oxford, Ohio, from 1993 until 1997. Mr. Piccin has handled complex divorce cases involving business interests and valuation, child custody disputes, and long-term support issues.

#### **Gary S. Wellbaum**

Mr. Wellbaum is a 1981 graduate of Ohio Northern University and a 1984 graduate of The Ohio State University, College of Law. Since 1991, Mr. Wellbaum has limited his practice exclusively to Family Law. He has been an Ohio State Bar Association Certified Family Relations Law Specialist since 2000. In 2003, he was selected to serve as a committee member on the ABA Family Law Section's Working Group on Same-Sex Marriages and Non-Marital Unions. The Group not only published a White Paper but also presented the topic as one of the ABA Presidential Showcase presentations at the national meeting in Atlanta in 2004. In 2005, Mr. Wellbaum was asked to serve as Co-Vice-Chair of the ABA Family Law Section's Committee on Alternative Families. He was re-appointed as Vice-Chair in 2006. Mr. Wellbaum lectures regularly on the topic of family law at the local, state, and national levels.

#### **Stacey A. Gilbert**

Stacey began her legal career as a Staff Attorney to Judge David Fais, Franklin County Court of Common Pleas, General Division. She then opened her own law firm, Gilbert Law Office, LLC. Next, Stacey was an associate attorney with a small Columbus firm. Subsequently, she became a Staff Attorney to Judge Elizabeth Gill, Franklin County Court of Common Pleas, Division of Domestic Relations and Juvenile Branch. a "Super Lawyer." Attorney Dougherty won a landmark victory in the Ohio Supreme Court in *Fisher v. Hasenjager* (2007), 116 Ohio St.3d 53, 2007-Ohio-5589, which addressed the underlying principles in shared parenting cases and defined when shared parenting orders and plans can be modified. Mr. Dougherty is a frequent speaker and author. He previously served as the Chairman of the Family Law Committee of the CBA. For his work as Chairman, he was given the President's Award in recognition of his leadership of the committee.
